- All applicants, whether new or those renewing their applications, must submit the Criminal History Disqualifiers List (Disqualifier List) with their application.
- Applicants must review the (Disqualifier List) prior to submitting their application. If any of
  the Disqualifiers apply, they should not submit a RACES application. If none of the
  Disqualifiers apply, they will sign the (Disqualifier List) and submit it with their RACES
  application. Once the (DRO / RRO) has received a complete package and completed their
  local processing / screening, they will submit the complete package to TDEM. Packages

- All applicants (new or renewals) will include their signed (Disqualifier List) with their RACES
  application. If Disqualifiers are found during the Criminal Background check, the application
  will be rejected. Failure to include the (Disqualifier List) with their RACES application will
  delay the processing of the application.

## Texas Division of Emergency Management Radio Amateur Civil Emergency Services (RACES) Applicant Criminal History Disqualifiers



Provided below are criminal history disqualifiers that are used by the Texas Division of Emergency Management (TDEM) when conducting background checks for individuals requesting enrollment in the State of Texas RACES Program.

A copy of this document signed and acknowledged by the applicant is required to be attached to the RACES application when submitted to TDEM for processing.

When it is determined that an applicant fits into any one of the below listed categories, the applicant **will not** be eligible to serve as a volunteer representing the Texas Division of Emergency Management RACES Program. The applicant will be rejected at once for factors including, but not limited to, the following:

- a. A felony conviction.
- b. An entering of an order of deferred adjudication for a felony, until five years after court supervision ceased and the case was dismissed.
- A conviction of driving while intoxicated during the five-year period immediately prior to the date of application.
- d. A finding by the court of competent jurisdiction that the applicant was a delinquent child during the five-year period immediately prior to the date of application. If the applicant's record in the proceeding is ordered sealed, the incident should be disregarded and treated as though it did not exist.
- e. The applicant's driver license has been suspended, including a probated suspension, by the Texas Department of Public Safety during the last three years as a habitual violator.
- f. The applicant's driver license has been suspended for refusal to submit to a chemical test within the last ten years.
- g. The applicant has an open/active arrest warrant in any state.
- h. The applicant is currently under indictment for any criminal offense.
- i. The applicant has an open disposition, an incomplete criminal record, or no final determination of guilt or innocence is found on the applicant's criminal record following a felony arrest.
