THIS NET IS ALERTED AFTER THE JCARC NET FOR THE PURPOSE OF TRAINING, MOTIVATION, PRACTICE IN EMERGENCY COMMUNICATIONS, AND THE GENERAL DISCUSSION OF EMERGENCY PROCEDURES AND PROBLEMS. PARTICIPATION IN THE NET BY ALL HAMS INTERESTED IN EMERGENCY OPERATIONS IS ENCOURAGED.

MEMBERSHIP IN ANY PARTICULAR AMATEUR RADIO CLUB OR ORGANIZATION IS NOT A REQUIREMENT FOR PARTICIPATION. ALTHOUGH THIS IS THE ARES NET, IT ALSO SUPPORTS THE NATIONAL WEATHER SERVICE, FEMA, LOCAL EMS, FIRE & POLICE DEPARTMENTS, THE RED CROSS, RACES, AND HOMELAND SECURITY, AND OTHER SERVED AGENCIES.

REMINDER, WE HAVE SET SIMPLEX FREQUENCIES OF 146.580 AND 145.560 IN THE EVENT OF REPEATER LOSS AND THE NATIONAL SIMPLEX CALLING FREQUENCY OF 146.520.

WHEN CHECKING IN, PLEASE STATE YOUR CALL, NAME, LOCATION, AND IF YOU HAVE ANY TRAFFIC FOR THE NET.

A CALL FOR STATIONS WITH EMERGENCY TRAFFIC IS FIRST, AND THEN A REQUEST FOR GENERAL CHECK-INS WILL FOLLOW. THIS IS (CALLSIGN) NET CONTROL.

ANY STATION HOLDING EMERGENCY TRAFFIC COME NOW.

ANY STATION WITH PRIORITY OR TIME-SENSITIVE TRAFFIC COME NOW.

IF YOU HAVE AN EMERGENCY DURING THIS NET, USE THE PRO-WORDS BREAK / BREAK AND IDENTIFY YOUR STATION, AND NET CONTROL WILL STAND BY FOR YOUR EMERGENCY.

GENERAL CHECK-INS COME NOW (ASK ALL CHECK-INS IF THEY HAVE ANY COMMENTS FOR THE NET.)
